ORDER

As per the Government Order read as 1st paper above, Shri. S. Narayanan, Municipal Secretary Grade III, Kalamassery Municipality and Shri. Sajikumar V, Municipal Secretary Grade III, Kunnamkulam Municipality were mutually transferred. Against this order, Shri.S.Narayanan submitted representation read as 2nd paper above before the Government and also filed O.A (EKM) No. 445/2016 before the Kerala Administrative Tribunal. As per the interim order dated 8/3/2016, the Hon'ble Kerala Administrative Tribunal stayed the transfer of the applicant. The Hon'ble Kerala Administrative Tribunal, as per the Order read as 4th aper above, disposed the case with the direction to the 1st Respondent (State of Kerala represented by the Principal Secretary to Government, Local Self Government Department) to consider and pass orders on Annexure A5 after hearing the applicant and the 3rd respondent (Shri.Sajikumar V., Municipal Secretary Grade III, Kunnamkulam Municipality), within a period of two months from the date of receipt of a certified copy of the order. The Hon'ble Kerala Administrative Tribunal has also permitted the applicant as well as the 3rd respondent to file appropriate written statements at the time of hearing of the matter. The Court made it clear that till then the interim order will continue.

2. As directed by the Hon'ble Kerala Administrative Tribunal, the applicant Shri. S. Narayanan, and the 3rd respondent Shri.Sajikumar V., were heard by the

- 3. During the hearing, the applicant Shri. S. Narayanan, Municipal Secretary Grade III, Kalamassery submitted that his grievance has already been settled as per the Government Order read as 5th paper above and he has no further grievance in the matter. The 3rd Respondent Sri. V. Sajikumar submitted that as the matter has been settled, he has no objection to file.
- 4. Government have examined the case in detail. The request in the Annexure A5 representation is to allow the applicant to continue in the present post. i.e Municipal Secretary Grade III in Kalamassery Municipality. The applicant, Shri. S. Narayanan obtained stay for the transfer. Thereafter Government issued Order read as 5th paper above, in which Shri. V. Saji Kumar, Secretary, Kunnamkulam Municipality was posted to Chitur, Thattamangalam Municipality.
- 6. In the above circumstances, no further orders is necessary on the request put forth in the Annexure A5 representation. With this observation, the Annexure A5 representation read as 2nd paper above is disposed of and the direction contained in the Order read as 3rd paper above of the Hon'ble Kerala Administrative Tribunal is complied with accordingly.
