ORDER

Smt.Chithra Vasu., was recruited through KPSC as Assistant Engineer (Civil) on 21/06/2007 A.N. The incumbent was placed under probation for a period of two years on duty within a continuous period of three years. She has availed LWA for 604 days for joining spouse before completing the probation and rejoined after LWA on 06/04/2009 FN. Hence her probation started with effect from 06/04/2009 FN. But she has not passed the obligatory Departmental Tests during the period of probation in the cadre of Assistant Engineer. The last date of the series of test in which she passed was 19-08-2015. Hence her period of probation has to be extended up to 21-08-2015 AN, so as to declare the probation on 20-08-2015 FN. As per the proceedings read as second paper above, the Chief Engineer, LSGD has extended the period of probation in respect of Smt.Chithra Vasu, Assistant Engineer up to 05.04.2012, AN and as per the letter read as 1st paper above, he has requested for the extension of the period of probation of the incumbent up to 21.08.2015 AN. The Chief Engineer has reported that the incumbent is otherwise eligible to have declared the period of probation but for her non passing of the obligatory Departmental Tests.

2. Government have examined the matter in detail and are pleased to extend the period for probation in respect of Smt.Chithra Vasu, Assistant Engineer from 06.04.2012 to 21.08.2015AN as per Rule 21 of Part II KS & SSRs, 1958.
