#### ORDER

Government as per the order read above had accorded sanction to set up an independent Social Audit Society in the state for the conduct of Social Audit of Mahatma Gandhi NREGS under the name Mahatma Gandhi NREGA Social Audit Society Kerala. The guidelines issued along with government order above stipulates that the management of affairs of the MGNREGA Social Audit Society shall be vested with governing body and Director of the Society. The governing body of the Social Audit Unit will be responsible for overseeing the performance of the unit on a periodic basis and provide necessary advice and direction as and when required. The guideline envisaged the governing body consisting of the following members.

- 1.Principal Secretary, LSGD (Chairperson)
- 2. Principal Accountant General
- 3. Five eminent citizens with long standing field experience on matter concerning transparency and accountability
- 4. Representatives of other departments undertaking social audits in their programmes.
- 5. Two members to be nominated by Government of Kerala to represent various. organisations involved in operationalisation of the Mahatma Gandhi NREG Scheme.
- 2. The Mission Director(MGNREGS) as per the letter read above has requested for the nomination of persons in the governing body for registration of the Mahatma Gandhi NREGA Social Audit Society Kerala under the Travancore-Cochin Literary, Scientific and Charitable Societies registration Act 1955. In the meanwhile the empowered committee headed by Additional Secretary, MoRD, Government of India suggested that any other Principal Secretary to Government shall chair the Governing body instead of Principal Secretary (LSGD).
