ORDER

Sanction is accorded for drawing and disbursing an amount of Rs.2,00,000/- (Two Lakhs Rupees only) as interest Free Medical Advance (IFMA) to Shri. Ajayakumar T.K., Overseer Grade II, LSGD Section, Nadathara Gramapanchayat, Thrissur District for his MRI Compatible Pacemaker treatment at Sree Chitra Tirunal Institute for Medical Sciences and Technology(SCTIMS&T), Thiruvananthapuram subject to the conditions specified in the Government Orders read 1st to 3rd papers above, by debiting the expenditure under the 'Head of account 7610-00-800-95(02)-IFMA to Non Gazetted Officers for the financial year 2016-17" and also to the conditions that Utilization Certificate duly countersigned by the Medical Officer of the Institution should be produced within 3 months from the date of drawal of the amount and the advance amount should be settled within 6 months. In case of default, penal interest @12% will be charged.

2. The Chief Engineer, LSGD shall ensure that necessary entries are made in the Service Book of the Loanee regarding the Interest Free Medical Advance mentioning amount, number and date of Government Order, Contingent Bill Number and the date of drawal of the loan.

3.The Chief Engineer, LSGD should also forward a copy of the Government Order sanctioning the Interest Free Medical Advance to Government in Finance(Loans) Department after indicating the name of the Treasury from where the advance is to be drawn, within one week of the issuance of this order. Date of encashment also to be intimated. In case of Non drawal/Cancellation of Interest Free Medical Advance, the said fact shall

also be reported to Government without fail. Unutilized amount, if any, should be refunded immediately.
