**ORDER**

Government in its order read as 1<sup>st</sup> paper above have decided to disburse the Social Security Pensions through District Co-operative Banks / Primary Agricultural Credit Societies /Other Credit Co-operatives.

2. Government are reviewing the progress of the disbursement of pension on a daily basis and issued instructions to sort out the issues in the implementation. Considering the extensive and time bound work done by the incumbents engaged in the programme, Government have sanctioned an amount of Rs.13,67,500/- as incentive to them vide GO read as second paper above and released an amount of Rs.3,33,500/- to the incumbents engaged from Information Kerala Mission and DBT Cell in the Directorate of Panchayat.

3. Government after having examined the matter in detail are pleased to release an amount of Rs.38,000/- (Rupees Thirty Eight thousand only) as incentive to the incumbents

engaged from Finance Department for the implementation of the Home Delivery of Social Security Pensions through the District Co-operative Banks (DCB) / Primary Agricultural Credit Societies (PACS) / Other Credit Co-operatives. The incentive for the incumbents engaged from Co-operative Department shall be issued later.

4. The DBT Cell in the Directorate of Panchayats is authorized to transfer credit the amount directly to the accounts of the incumbents as mentioned in the Annexure,


