- 2. As per the Government Order read as 2nd paper above, Government have constituted at team of officers for conducting inspection at the Kozhikode Corporation Office to trace out the file and to find out the officers responsible for the missing of the file.
- 3 Government have reconsidered the mater and are pleased to appoint the Regional Joint Director of Urban Affairs, Kozhikode to conduct a detailed inspection in the Kozhikode Corporation office to trace out the file and to fix the responsibility.
