**ORDER**

Executive Director, Suchitwa Mission informed that vide letter read as first paper above, Ministry of Drinking Water and Sanitation, Government of India, an amount of **Rs. 57,01,15,000/- (Rupees Fifty Seven Crore One Lakh Fifteen Thousand only)** has been released towards the first installment of Grant in Aid during 2016 -17 for the implementation of SBM (G) to state consolidated Fund as follows

1. Normal Allocation ( Non SCP & Non TSP ) - ( Sanction Order No.128/2016-17 dated 22.09.2016 )	Rs. 48,20,17,000/- (Forty Eight Crore Twenty Lakh Seventeen Thousand only)
2.Special Component Plan for Scheduled Castes - (Sanction Order No.129/2016- 17 dated 22.09.2016 )	Rs.8,16,08,000/- (Eight Crore Sixteen Lakh Eight Thousand only)
3.Tribal Area Sub Plan - (Sanction Order No. 130/2016- 17 dated 22.09.2016 )	Rs. 64,90,000/- (Sixty Four Lakh Ninety Thousand only)
<b>Total</b>	<b>Rs. 57,01,15,000/-(Rupees Fifty Seven Crore One Lakh Fifteen Thousand only)</b>

Based on the directions from Ministry of Drinking Water and Sanitation ,Government of India, the Executive Director, Suchitwa Mission requested to accord sanction to the release of the Central Share of Rs. 57,01,15,000/- ( Rupees Fifty Seven Crore One Lakh Fifteen Thousand only) from the head of account 2515-00-101-65(01) and the corresponding matching State Share of Rs.38,00,76,666/- ( Rupees Thirty Eight Crore Seventy Six Thousand Six Hundred and Sixty Six only), calculated in the ratio of 60:40 for three components as follows, from the head of account 2515-00-101-65(02) with permission to the Commissioner for Rural Development to draw and to transfer credit the amount to the Special TSB Account No.99 of Executive Director, Suchitwa Mission at District Treasury Thiruvananthapuram.

1.Normal Allocation (Non SCP& Non TSP)	Rs. 32,13,44,667/- (Thirty Two Crore Thirteen Lakh Forty Four Thousand Six hundred and Sixty Seven only)
2.Special Component Plan for Scheduled Castes	Rs.5,44,05,333/- (Five Crore Forty Four Lakh Five Thousand Three Hundred and Thirty Three only)
3.Tribal Area Sub Plan	Rs.43,26,666 (Forty Three Lakh Twenty Six Thousand Six Hundred and Sixty Six only)

As per the U O Note read as 2<sup>nd</sup> paper above, Finance Department agrees to release of central share of Rs.4820.17 lakh and the corresponding state share of Rs. 3213.45 lakh towards SBM(G) from the provision under the Head of Account 2515-00-101-65(01)-(PV) and 2515-00-101-65(02) – (PV) respectively. It is also informed that sanction is accorded to release the Central and State share of SCP and TSP component of the scheme through re appropriation vide Government Order read as third above with permission to the Commissioner for Rural Development to draw and to transfer credit the amount to the Special TSB Account No.99 of Executive Director, Suchitwa Mission at District Treasury Thiruvananthapuram.

Based on the request from the Executive Director, Suchitwa Mission Government have examined the matter in detail and are pleased to accord sanction to the release of central share Rs.4820.17 lakh and the corresponding state share of Rs. 3213.45 lakh towards SBM(G) from the provision under the head 2515-00-101-65(01)-(PV) and 2515-00-101-65(02) – (PV) respectively. Sanction is also accord to the release of Central and State share of SCP and TSP component of the scheme as mentioned above through re appropriation vide Government Order

read as third paper above. Permission is also granted to the Commissioner for Rural Development to draw and to transfer credit the amount to the Special TSB Account No.99 of Executive Director, Suchitwa Mission at District Treasury Thiruvananthapuram.

The guidelines of the scheme shall strictly be followed during the implimentation process


