ORDER

Government have modified the nature and number of Local Governments during 2015-16 to the extent of creation of 28 new Municipalities and one new Municipal Corporation. Government in its notification read as 3rd paper above have constituted the Anthoor Municipality by dividing the Thalipparamba Municipality and have allocated funds between the Thalipparamba and Anthoor Municipality on the basis of the population. Unlike other newly created Local Governments, Anthoor Municipality has no infrastructure like office building, vehicle, staff etc., Moreover it is a lone case in the state. The Anthoor Municipality in its letter read as 4th paper above have requested to sanction an amount of Rs. 500 lakh to them for creating infrastructure for the functioning of the Municipality.

Government have examined the matter in detail and are pleased to issue the following orders.

1. An authorization of Rs. 75, 00,000/- (Rupees Seventy Five lakh only) is sanctioned to the Anthoor Municipality under General Purpose Fund.
2. Director of Treasuries shall make available copies of this order to the District / Sub Treasuries with digital signature of the Director of Treasuries through Treasury intranet.
3. Treasury officers shall treat this order as an allotment letter, only when received with the digital signature of the Director of Treasuries, through Treasury intranet only.
4. Secretary of Local Government shall submit a bill in TR 59 (C) to the Treasuries for transfer crediting the share of General Purpose fund due to them from the Consolidated Fund to the Special Treasury Savings Bank Account (Special TSB) of the Local Government.
5. The Head of Account from which the amount is to be drawn is 3604-00-200-88-(02)- NP.
6. Treasury officers are also directed to report the details of the transfer credit as a periodical to the Director of Treasuries and Government in Finance (SFC Cell) Department on the same date of transfer credit.
7. The Secretary of Local Governments shall draw the amount from the respective Special Treasury Savings Bank Account by presenting TSB cheques.
