O<u>RDER</u>

Government is planning to implement Public Grievance Redressal System for Local Self Government Institutions with the objective to monitor and redress / reply to all grievances received in the department at any level in a transparent way. As part of launching of the said System for facilitating citizens to post their complaints related to various services from the LSGD and its line departments / agencies, a public grievance module is being developed by the National Informatic Centre which is scheduled to be rolled out on 02.11.2016. In this connection, Kerala State IT Mission has submitted a proposal for the release of fund for an amount of \mathbf{R} 1,69,000/- (Rupees One Lakh Sixty Nine Thousand Only) for providing training to the Support Engineers in each e-District and to the Master Trainers. The estimated expenditure for the above training is as shown below:
