ORDER

As per Order read as 1st paper above, the Director of Urban Affairs issued transfer and postings and promotions in the cadre of Superintendent of Municipal Common Service. In that Order one Sri. S. Jayakumar, Superintendent Thiruvananthapuram Corporation has been transferred to Nilambur Municipality on administrative convenience. Against this order, Sri. S. Jayakumar filed appeal petition read as 2nd paper above before the Government. In the appeal

Superintendent on 7/2012 and many of his seniors are still working in Thiruvananthapuram Corporation. He complained that without transferring them he was transferred to Nilambur Municipality. He added that his aged mother is bed-ridden and he is the only son. He submitted that at the time of his transfer, there were 7 vacancies of Supdts in Thiruvananthapuram Corporation and intention behind his transfer was to accommodate 5 Revenue Inspectors who were given promotion as Supdts. He therefore requested to retain him Thiruvananthapuram Corporation.

- 2. In connection with the above transfer, Sri. S. Jayakumar filed O.A No. 1734/2016 before the Kerala Administrative Tribunal. The Hon. Tribunal in the Order read as 3rd paper above directed the 1st Respondent, Secretary to Government, LSGD to consider and pass orders on Annexure A3 Appeal within two months from the date of receipt of a copy of the order, after affording an opportunity of being heard to the applicant.
- 3. In accordance with the direction of the Hon. Kerala Administrative Tribunal, Sri.S. Jayakumar was heard by the Under Secretary to Government, Local Self Government Department on 18/10/2016. During the hearing the appellant submitted that 4 Revenue Inspectors were allowed to continue in Thiruvananthapuram Corporation on promotion as Supdts and 3 existing Supdts who are completed more years than the service period of the applicant in Thiruvananthapuram Corporation are retained in Thiruvananthapuram Corporation without transfer. He produced medical certificate of his mother and requested to retain him in Thiruvananthapuram Corporation.
 - 4. Government have examined the Annexure A3 Appeal petition read as 2nd paper above in detail with the report read as 4th paper above of the Director of Urban Affairs and with the transfer norms of Local Self Government Department issued under GO (Ms) No 105/2007/LSGD dated. 4/4/2007. As per Para II and III of this order an employee who completed 3 years service can be transferred out. In this case, at the time of transfer, the appellant had completed 4 years service in Thiruvananthapuram Corporation. The Director of Urban Affairs transferred the incumbent for administrative convenience. In the letter read as 4th paper above, the Director of Urban Affairs has submitted that the incumbent was continuing in Thiruvananthapuram Corporation from 2012 onwards and transfer request of many officers who were working in remote Municipalities has to be considered and by that reason the incumbent was transferred to Nilambur Municipality. However, the Director of Urban Affairs submitted

that he will consider the application of appellant for transfer and will be given a more convenient posting in any of the Municipalities in accordance with eligibility.

5. Considering the fact and circumstances of this case, Government are of the view that there is no need to interfere the transfer order read as $1^{\rm st}$ paper above of the Director of Urban Affairs. The request in the Annexure A3 appeal petition read as $2^{\rm nd}$ paper above of Sri. S. Jayakumar, Superintendent is therefore rejected and orders accordingly.

6. The direction contained in the Order read as 3rd paper above of the

Hon. Kerala Administrative Tribunal is complied with as noted above.
