**ORDER**

Kum. Sooryaja. R. Kiran, D/o Late. Jyothi.P, former Extension Officer (Women Welfare) , Block Development Office, Panthalayani residing at Jyothis, Pipe Line Road, Malaparamba, Kozhikkode, as per her application read as 2<sup>nd</sup> paper above has applied for employment assistance under Compassionate Employment Scheme. The matter was enquired through the District Collector, Kozhikkode and has recommended the request for employment assistance as per the report read as 4<sup>th</sup> paper above.

Smt. Jyothi.P expired on 13.05.2013, while working as Extension Officer (Women Welfare) , Block Development Office, Panthalayani, Rural Development Department. She had put in a total service of 20 years 10 months and 12 days at the time of her death. Her daughter Kum. Sooryaja. R. Kiran has applied for employment assistance under the scheme. All other dependents have relinquished their claim for employment assistance in favour of the applicant.

Kum. Sooryaja. R. Kiran has passed S.S.L.C and Higher Secondary Examination. She is aged 21 years. Her date of birth is 18.02.1995. She has requested for appointment as Lower Division Clerk in Rural Development Department in Kozhikkode District. The applicant satisfies all the conditions for being appointed as Lower Division Clerk .

In the circumstances reported by the Commissioner for Rural Development, Thiruvananthapuram and the District Collector, Kozhikkode in their letters read as 3<sup>rd</sup> and 4<sup>th</sup> papers above and as per the provisions contained

in the Government Order read as 1<sup>st</sup> paper above, sanction is accorded for the appointment of Kum. Sooryaja. R. Kiran, D/o Late. Jyothi.P, former Extension Officer (Women Welfare) , Block Development Office, Panthalayani, Kozhikkode residing at Jyothis, Pipe Line Road, Malaparamba, Kozhikkode in the existing/ arising vacancy of Lower Division Clerk in the Rural Development Department in Kozhikkode District subject to the provisions governing the scheme. The Commissioner for Rural Development will issue formal posting orders to the applicant. Kum. Sooryaja. R. Kiran will produce a copy of her photograph, recently taken, duly attested by a Gazetted Officer before the Commissioner for Rural Development at the time of joining duty. Before admitting her to duty, the original documents in proof of her age, educational qualification and medical fitness should be verified. Her character and antecedents will also be got verified through the Police Department in due course. If the appointment is in a District other than the District of option for want of vacancy, she will be given transfer to the District of option in the next arising vacancy without loss of seniority. The five year rule prescribed for inter-district transfer of district-wise recruits will be made applicable in this case from the date of posting to the district of her choice. The details of appointment under the scheme will be entered in the Service Book of the deceased Government employee and also in the Establishment Register of the office in which the Government employee last worked and the fact will be attested by Head of office/Head of the Department.

The appointment will be cancelled if and when it is found that there was misrepresentation or suppression of material facts at the time of applying for appointment under the Compassionate Employment Scheme or during the course of the enquiry by the departmental authorities.


