O R D E R

As per the Government Order read as 1st paper above, administrative sanction was accorded for establishing 30 Grama Nyayalayas in the state including one at Kulanada Block. Later after re-organisation of block panchayaths the Kulanada Block Panchayath was integrated with the Pandalam Block Panchayath. Sanction was accorded as per Government Order read as 2nd paper above to State Bank of Travancore (SBT) to construct a building for Rural Self Employment Training Institute (RSETI) in the land occupied by the erstwhile Pandalam Block Panchayath. Later as per the Government Order read as 3rd paper above, permission was granted to SBT to establish RSETI at the office building of the erstwhile Pandalam Block Office at Pandalam subject to certain conditions. As per Government Order read as 4th paper above, Government shifted the Grama Nyayalaya allotted at Kulanada to Pandalam.

Meanwhile the Pandalam Block Panchayath filed WP(C)10990/14 before the Hon'ble High Court praying to quash the Government Order read as 3rd paper above so as to establish Grama Nyayalaya in the said building. In the order read as 5th paper above, the Hon'ble High Court has directed Government to issue orders to

handover the building of the erstwhile Pandalam Block Panchayat with sufficient space for the purpose of establishing Grama Nyayalaya.

In the above circumstances the Commissioner for Rural Development is directed to handover sufficient space at the office building of the erstwhile Pandalam Block Panchayat for establishing Grama Nyayalaya sanctioned at Pandalam as per Government Order read as 4th paper above.

The direction of the Hon'ble High Court in the order read as 5th paper above is complied with accordingly.
