ORDER

Sri.K.T.Rajan, Executive Engineer has filed O.A.No.1384/2015 before the Hon'ble KAT aggrieved by denial of promotion to him as Superintending Engineer. As per the order read as second paper above, the Hon'ble KAT has disposed of the OA with a direction to dispose the Annexure A11-A12 representations filed by the applicant read as 1st paper above respectively, by placing them before the Departmental Promotion Committee(DPC) or Review DPC, as the case may be, in accordance with law, within 3 months of receipt of a copy of the said order.

2.In the representation dated 08.05.2015, Sri.K.T.Rajan, Executive Engineer had contended that he was denied of promotion to the cadre of Superintending Engineer and had requested to consider him for provisional promotion to the cadre of Superintending Engineer by placing his request in the upcoming DPC. In the representation dated 14.05.2015 he had claimed retrospective promotion to the cadre of Superintending Engineer.

3.The claim of Sri.K.T.Rajan, Executive Engineer, for promotion to the cadre of Superintending Engineer as raised in Annexure A11 and A12 representations has been placed before the Departmental Promotion Committee (Higher) held on 01-10-2016 as an Additional Note, in pursuance to the order of Hon'ble KAT read as 2nd paper above. The committee had examined the claim of Sri.K.T.Rajan and it was decided that his prayer for promotion to the cadre of Superintending Engineer as raised in the Annexure A11 and A12 representations cannot be considered in view of the pendency of disciplinary action initiated for imposition of major penalty.

5. Government have examined the matter in detail and the prayer of Sri K.T.Rajan, Executive Engineer in the representations dated 08.05.2015 and 14.05.2015 is hereby rejected, in view of the decision of the Departmental Promotion Committee held on 01.10.2016. The orders of the Hon'ble KAT in OA No.1584/15 is complied with accordingly.
