ORDER

Sri. K. Pradeep Kumar, recruited through the KPSC as First Grade Overseer. and subsequently promoted as Assistant Engineer who have joined duty in the promoted post on the FN of 03-04-2001 has not passed the obligatory Departmental Tests during the normal period of probation in the cadre of Assistant Engineer. The last date of the series of departmental tests in which he had passed was 02-03-2012. Hence his period of probation in the cadre of Assistant Engineer has to be extended up to 04-03-2012 AN, so as to declare the probation on 03-03-2012 FN. He has participated in strike for 31 days other than casual leave during the probation period.

2. As per the proceedings read as second paper above, the Chief Engineer, LSGD has extended the period of probation in respect of Sri. K. Pradeep Kumar, Assistant Engineer up to 03-05-2004 AN and as per the letter read as 1st paper above, he has requested for the extension of the period of probation of the incumbent up to 04-03-2012 AN. The Chief Engineer has reported that the incumbent is otherwise eligible to have declared the period of probation but for his non passing of the obligatory Departmental Tests.

3. Government have examined the matter in detail and are pleased to extend the period for probation in respect of Sri. K. Pradeep Kumar, Assistant Engineer in the cadre of Assistant Engineer from 04/05/2004 to 04/03/2012 AN as per Rule 21 of Part II KS & SSRs, 1958.
