As per order read as 1st paper above, the Director of Urban Affairs issued transfer, postings and promotions in the cadre of Superintendents of Municipal Common Service. In that Order, Shri. P. Rajan, Revenue Inspector/Head Clerk, Thrikkakara Municipality has been promoted and posted in Kasargod Municipality. Against this Order, Shri. P. Rajan filed appeal petition read as 2nd paper above before the Government. In the appeal he submitted that he is a native of Payipra Grama Panchayat of Ernakulam District. Even though there were vacancies of Superintendents in Kochi, Kothamangalam, Kalamassery, Maradu and North Paravur Municipalities, the Director of Urban Affairs posted him Kasargod Municipality and his juniors were allowed to continue in their Municipalities even after granting promotion.
