ORDER

The Hon. Kerala Administrative Tribunal made it clear that while producing a copy of the order the applicant shall produce a copy of the Original Application also before the Government.

(3) In the petition read as 5th paper above, the applicant informed Govt. that he got posting in Kannur Municipality as per the order of the Director of Urban Affairs read as 4th paper above.

(4) Thus the Order of the Hon. Kerala Administrative Tribunal read as 3rd paper above is complied with accordingly.
