ORDER

1. Smt. Deepika R., D/o late Sri.S.Rajendran, who died in harness while in service Section Officer, Greater Cochin Development Authority (GCDA), residing at Sreepadam, Police Station Road, Chengamanad P.O., Ernakulam Dist, PIN – 683578 as per paper read as 3rd above has applied for employment assistance under the Compassionate Employment Scheme (CES). The Secretary, GCDA as per paper read read as 4th paper above has forwarded a proposal in this regard. The matter was enquired through the District Collector, Ernakulam and he had recommended the request as per paper read as 5th paper above.
2. Sri. S. Rajendran, has expired on 03.08.2010 while in service in GCDA as Section Officer. He had put in a total service of 24 years, 6 months and 25 days at the time of his death. His daughter Smt. Deepika R., has applied for employment assistance under the Compassionate Employment Scheme. All other dependents have relinquished thier claim for employment assistance in favour of the applicant. The applicant had passed SSLC. Her date of birth is 08.2.1995. She has requested for appointment as LD Clerk in GCDA and she satisfies all the conditions for being appointed to the post.

In the circumstances as reported by the Secretary, GCDA and the District Collector, Ernakulam in their letters read as paper 4th and 5th respectively, and as per the provisons contained in the GO read as 1st & 2nd paper above, Government are pleased to accord sanction for the appointment of Smt. Deepika R., D/o Late S. Rajendran, Section Officer, GCDA, (residing at Sreepadam, Police Station Road, Chengamanad P.O., Ernakulam Dist, PIN – 683578) as Lower Division Clerk in GCDA in the existing /next arising vacancy under the Compassionate Employment Scheme. The appointment will be subject to the availability of existing/arising vacancy of LD Clerk in GCDA subject to provisions governing

the scheme. The Secretary, GCDA will issue formal appointment orders and will ensure the authenticity of her credentials. The details of appointment under the scheme will be entered in the Service Book of the deceased Government employee.

4. The appointment will be cancelled if and when it is found that there was misrepresentation or suppression of material facts at the time of applying for appointment under the Compassionate Employment Scheme or during the course of enquiry by departmental authorities. Government will have the right to cancel the order sanctioning this appointment under the Compassionate Employment Scheme, if after the issue of this order, it is seen on examination that the orders were issued erroneously.
