ORDER

The Ministry of Housing & Urban Poverty Alleviation, Government of India vide their letter read above conveyed the sanction of Rs. 50,69,40,000/- (Rupees Fifty Crore Sixty Nine Lakh and Forty Thousand only) as First installment (40%) to the State Government as central assistance for Creation of Capital Assets under Pradhan Mantri Awas Yojana (Urban) under Plan allocation for the financial year 2016 - 2017 for implementation of the scheme in four corporations and seven municipalities of the state. The corresponding state share of the first installment of the central assistance of Rs. 50,69,40,000/- at the rate of 40% is Rs. 16,89,80,000/- (Rupees Sixteen Crore Eighty Nine Lakh and Eighty Thousand only).

The Executive Director, Kudumbashree in his letter read as second paper above requested Government to release the first installment of central assistance (40%) along with corresponding state share amounting to a total of Rs. 67,59,20,000/-.

Government have examined the proposal in detail and are pleased to accord sanction for the release of a total amount of Rs. 67,59,20,000/- (Rupees Sixty Seven Crore Fifty Nine Lakh and Twenty Thousand only), as central assistance and corresponding state share, to the Executive Director, Kudumbashree, ie, Rs. 35,86,40,000/- (Rupees Thirty Five Crore Eighty Six Lakh and Forty Thousand only) for 7 Municipalities from the H/a 2217-05-192-72-PMAY - 40%

SS (Plan)- (For Municipalities) and Rs. 31,72,80,000/- (Rupees Thirty One Crore Seventy Two Lakh and Eighty Thousand only) for 4 Corporations from the H/a 2217-05-191-74-PMAY-40% SS (Plan)–(For Corporations) for the implementation of the Pradhan Mantri Awas Yojana (Urban) in the state for the year 2016 – 2017 as per the list appended to this order.
