ORDER

Smt.Prameela P.P., recruited through KPSC as Overseer Grade I was subsequently promoted to the cadre of Assistant Engineer and she joined duty in the promoted post on 30.06.2010 FN. She has not passed the obligatory Departmental Tests during the normal period of probation in the cadre of Assistant Engineer. The last date of the series of test in which she passed was 05-08 2013. Hence her period of probation has to be extended up to 07-08-2013 AN, so as to declare the probation on 06-08-2013 FN. She has availed Earned Leave for 30 days from 28.03.2011 to 26.04.2011. As per the proceedings read as second paper above, the Chief Engineer, LSGD has extended the period of probation in respect of Smt.Prameela P.P, in the cadre of Assistant Engineer up to 29.06.2013 AN and as per the letter read as 1st paper above, he has requested for the extension of the period of probation of the incumbent up to 07.08.2013 AN. The Chief Engineer has reported that the incumbent is otherwise eligible to have declared the period of probation but for her non passing of the obligatory Departmental Tests.

2. Government have examined the matter in detail and are pleased to extend the period for probation in respect of Smt.Prameela P.P., in the cadre of Assistant Engineer from 30.06.2013 to 07.08.2013 AN as per Rule 21 of Part II KS & SSRs, 1958.
