**ORDER**

Shri.Muhammad Ismail K.T., recruited through KPSC as Assistant Engineer  
(Civil) on 23.01.2012 FN has not passed the obligatory Departmental Tests during  
the normal period of probation in the cadre of Assistant Engineer. The last date of  
the series of test in which he passed was 19-08-2015. Hence his period of  
probation has to be extended up to 21-08-2015 AN, so as to declare the probation  
on 20-08-2015 FN. As per the proceedings read as second paper above, the Chief  
Engineer, LSGD has extended the period of probation in respect of  
Shri.Muhammad Ismail K.T., in the cadre of Assistant Engineer up to 22.01.2015  
AN and as per the letter read as 1<sup>st</sup> paper above, he has requested for the  
extension of the period of probation of the incumbent up to 21.08.2015 AN. The  
Chief Engineer has reported that the incumbent is otherwise eligible to have  
declared the period of probation but for his non passing of the obligatory  
Departmental Tests.

2. Government have examined the matter in detail and are pleased to  
extend the period for probation in respect of Shri.Muhammad Ismail K.T , in the  
cadre of Assistant Engineer from 23.01.2015 to 21.08.2015 AN as per Rule 21 of  
Part II KS & SSRs, 1958.
