Government vide order read above have accorded authorisation of Rs.17101543/- to Grama Panchayats and Rs.26603889/- to Municipalities as Gap Fund for 2015-16. The following modifications are made in the Government order read above.

1.The amount sanctioned as Gap fund to eligible Grama Panchayats is to be read as Rs. 17101543/- (Rupees One crore Seventy One lakh One Thousand Five Hundred and Forty Three only ) instead of Rs.17101545/-.

2.The amount sanctioned as Gap fund to eligible Municipalities is to be read as Rs. 26603889/- (Rupees Two crore Sixty Six lakh Three Thousand Eight Hundred and Eighty Nine only ) instead of Rs.43705434/-.

3.The Head of Account to which the expenditure is to be debited is 3604-00-200-88(05)NP for Grama Panchayats and 3604-00-200- 88(02) NP for Municipalities.
