ORDER

(1) As per the Government Orders read as papers 1st to 5th above, Government have accorded administrative sanction for the following projects.

- Construction of Parking Plaza, internal road, rehabilitation block etc at Chalai.
- Construction of 'M' Block at Palayam.
- Construction of Bus stand cum commercial complex at Kazhakootam.
- Construction of 'A' Block, Palayam
- Easy Walk-East Fort-Thampanoor

(2) The Secretary, TRIDA as per the letter read as 6th paper above, requested to accord sanction to utilize the fund of Rs.30 crores available under the h/a 2217-05-191-36(plan) for the above projects.

(3) Government have examined the matter in detail and are pleased to accord sanction to release Rs. 10 crore from the h/a 2217-05-191-36-35(P) for the following projects as detailed below.

1. Construction of 'M' Block at Palayam. -5 Crores
2. Construction of Parking Plaza,
internal road, rehabilitation block etc at Chalai. - 3 Crores
3. Construction of Bus stand cum commercial
complex at Kazhakootam - 2 Crore

(4) The Secretary, TRIDA shall furnish the UC for the amount so far released for each project along with supporting documents, progress of each work/ Projects and the balance available in TSB account for considering further release of fund.


