## ORDER

Government in its order read as 2nd paper above have implemented the Universal Social Security pension and enhanced the rate of Social Security Pension and Welfare Fund Board pension to Rs 1000/month. Interalia Government have decided to verify the Aadhar details of pensioners to check and ensure that not morethan one pension is receiving by a pensioner. The process of seeding of Aadhar details is progressing. In the review meeting of the Chief Executive officers of Welfare Fund Boards, it has been informed that the boards are experiencing much difficulty to collect the Aadhar details of pensioners who are residing at distant and scattered areas and requested to entrust the collection of data of such pensioners to Kudumbashree. The Kudumbashree in its proposal read as 5th paper have reported that the existing rate of remuneration for the data collection is not sufficient for such locations and requested to enhance the same.

- 2) Government have examined the matter in detail and are pleased to modify the rate of remuneration for the data collection of Welfare Fund Board pensioners in distant and scattered areas as detailed below.
- i) In case the number of data is less than 100 in a Local Government, an additional remuneration of Rs 200/- is sanctioned for the collection of data.
- ii) Considering the geographical constraints in Idukki and Wayanad districts, the additional remuneration is fixed as Rs 300/-.

iii)The Program Manager, Kudumbashree should furnish a certificate from the concerned Welfare Fund Board to the above effect for the consideration of the additional

iv)The expenditure on this account shall be met from the interest portion of the SB account No.67234515304 maintained for disbursement of Social Security Pension with the SBT Main Branch, Thiruvananthapuram in the name of Director of Panchayats.
