ORDER

In the final order dated 20/12/2016 in OA 2658/2016 filed by Smt.Sruthy Singh, the Hon'ble Kerala Administrative Tribunal has directed to consider Annexure A7 representation after affording an opportunity of being heard to the applicant within a period of 6 weeks from the date of receipt of a copy of the judgement. In the A7 representation the applicant has requested to transfer her to any one of the Grama Panchayaths near her residence at Kadakkavoor since she is medically advised to avoid frequent travel.

2. As directed by the Hon'ble KAT, the applicant was heard by the Deputy Secretary to Government, Local Self Government Department on 07/02/2017. She has stated that she is not in a position to travel more than 135 km. to Alappuzha Municipality. She has produced Medical Certificate in this regard. She has requested to post her at least within Thiruvananthapuram District.

3. The Chief Engineer has reported that the stations mentioned by the applicant are not vacant now and since the project implementation is progressing in Local Self Government Institutions, transfer of an implementing officer will badly affect the execution of the works. Hence he has informed that the request of the applicant shall be considered in the next General Transfer.

4. The Government have examined the matter in detail. Considering the fact that the project implementations are at the final stages in the lag end of

the financial year, Government have taken a decision that the request of Smt.Sruthy Singh can be considered only in the next financial year. Accordingly, the Chief Engineer, LSGD who is the appointing authority in respect of Assistant Engineers, is hereby directed to consider the request of Smt.Sruthy Singh in the next financial year,ie, during the month of April, 2017 itself, and to furnish Report of Compliance to the Government and the Advocate General forthwith. The order of the Hon'ble KAT read as paper 2 above is complied with accordingly.
