ORDER

Smt. Neethu. K.S and 3 others filed OA (737/2016) before the Hon'ble Kerala Administrative Tribunal in which Secretary to Government, LSGD is the 2nd respondent. The substantial relief sought for is to direct the Government to take a decision on Annexure A3 representation, wherein they have requested the Government to invoke its power under Rule 39 of Part II KS&SSR and give appointments to 47 candidates from the ranked list of Lower Division Clerks (Kozhikode) (Category No. 477/2010) dated 30.03.2012 in accordance with seniority and communal rotation.

2. The Hon'ble Kerala Administrative Tribunal in their order read as 1st paper above have directed the respondents 2 to 10 to take appropriate decision on Annexure A3 and similar representation by the respective number respondents after hearing the applicants within four months from the date of receipt of the order. The petitioners were heard by the Deputy Secretary, LSGD.

3. The Director of Panchayats has reported 30 anticipated vacancies to the Kerala Public Service Commission (KPSC) and the KPSC has advised all of them and they had been given appointment in Panchayat Department. The 12 vacancies which were mentioned in the OA (737/2016), filed by Smt. Neethu. K.S and others were also included in the 30 vacancies reported to the KPSC.

4. Government have examined the matter in detail. Main grievance in the A3 representation is that the appointing authorities have not reported 12 vacancies to PSC in accordance with the direction contained in G.O (P) No. 13/15/P&ARD, dated 21.03.2015. Hence they have requested to invoke Rule 39 of Part II, KS&SSR. The Director of Panchayats has reported that the 12 vacancies have already been reported to PSC and they were appointed in the Department. Hence no further action invoking Rule 39, Part II KS&SSR is necessary. Hence the request of the applicants is rejected.


5. The order of Hon'ble Kerala Administrative Tribunal read as 1st paper above is complied with accordingly.
