ORDER

Sri.N.T.Abdulkareem BDO (Rtd.), who commenced his service as Village Extension Officer, and while working as Joint Block Development Officer, was promoted to the cadre of Block Development Officer under Rule 9 (a) (I), Part II, KS&SSR as per the Order No. Estt.B1/13868/10/CRD dated 5.6.10 of Commissioner for Rural Development, Thiruvananthapuram. Accordingly, the applicant took charge as Block Development Officer, Irikkur Block and his pay was fixed at Rs.28,040/- under Rule 28A of KSR Part I and he was retired from service on superannuation on 30.9.2012.

2) Shri.N.T.Abdulkareem had submitted representations to CRD (Annexure A7) and Principal Secretary, LSGD (Annexure A8), in which he stated that even though he was entitled for his increments at the time interval as fixed by the Government from time to time, ie on 30.6.2011 and 1.6.2012, he had not granted any increments during these dates and he retired from service on superannuation on 30.9.2012 without getting any increments for 28 months. He was drawing the same basic pay from the date of taking charge as B.D.O on 30.6.2010 to 30.9.2012, the date of superannuation. Aggrieved by the denial of annual increments, he filed OA 746/2016 before the Hon'ble Kerala Administrative Tribunal. The Hon'ble Kerala Administrative Tribunal, in its final order dated 30.11.2016 directed the first respondent, ie. Secretary to Govt. to consider and pass orders on Annexure A8 representation within a period of three months from the date of receipt of a copy of the order. The copy of the order received in Government on 4.1.2017 and the time limit of complying the order is on 3.4.2017.

3) Government have already issued clarification regarding the fixation of pay and subsequent increments to the provisionally promoted employees under Rule 31 (a) (i) of Part II KS & SSR as per the Government Order 3rd cited. Hence, Government are pleased to direct the Commissioner for Rural Development to apply the direction in the Government Order 3rd cited to this case also for granting annual increments to Sri.N.T.Abdul Kareem, Block Development Officer (Rtd.) on 30.06.2011 and 01.06.2012 and to refix the pay of the applicant on the basis of the increments sanctioned and pay the arrears of salary, and to refix the pension and all retirement benefits to him.

4) The order of the Hon'ble Kerala Administrative Tribunal is complied with accordingly.
