ORDER

Smt.Parvathy Unnithan. L , recruited through the Kerala Public Service Commission as Assistant Engineer (Civil) and joined duty on 25.05.2012 FN, has not passed the obligatory Departmental Tests during the normal period of probation in the cadre of Assistant Engineer. The last date of the series of test in which she passed was 18-02-2016. Hence her period of probation has to be extended up to 20-02-2016 AN, so as to declare the probation on 19-02-2016 FN. She has availed LWA for 21 days from 31.05.2012 to 20.06.2012 and LWA for 17 days from 21.06.2012 to 07.07.2012. As per the proceedings read as second paper above, the Chief Engineer, LSGD has extended the period of probation in respect of Smt.Parvathy Unnithan. L, in the cadre of Assistant Engineer up to 01.07.2015 AN and as per the letter read as 1st paper above, he has requested for the extension of the period of probation of the incumbent up to 20.02.2016 AN. The Chief Engineer has reported that the incumbent is otherwise eligible to have declared the period of probation but for her non passing of the obligatory Departmental Tests.

2. Government have examined the matter in detail and are pleased to extend the period for probation in respect of Smt.Parvathy Unnithan. L, in the cadre of Assistant Engineer from 02.07.2015 to 20.02.2016 AN as per Rule 21 of Part II KS & SSRs, 1958.
