ORDER

Sri.Ullasan C.P., recruited through the Kerala Public Service Commission as Overseer Grade I and subsequently promoted and joined duty as Assistant Engineer (Civil) on 09.08.2012 FN, has not passed the obligatory Departmental Tests during the normal period of probation in the cadre of Assistant Engineer. He has attained the age of 50 years on 03.04.2016 as his date of birth 03.04.1966. Hence, he is exempted from passing the obligatory departmental tests as per Rule 13(B) of Part II KS & SSRs, 1958 . Forwhich, his period of probation has to be extended up to 04-04-2016 AN, so as to declare the probation on 03-04-2016 FN. As per the proceedings read as second paper above, the Chief Engineer, LSGD has extended the period of probation in respect of Sri.Ullasan C.P., in the cadre of Assistant Engineer up to 08.08.2015 AN and as per the letter read as 1st paper above, he has requested for the extension of the period of probation of the incumbent up to 04.04.2016 AN. The Chief Engineer has reported that the incumbent is otherwise eligible to have declared the period of probation but for his non passing of the obligatory Departmental Tests.

2. Government have examined the matter in detail and are pleased to extend the period for probation in respect of Sri.Ullasan C.P., in the cadre of Assistant Engineer from 09.08.2015 to 04.04.2016 AN as per Rule 21 of Part II KS & SSRs, 1958.
