ORDER

As per the Government Order read as 1st paper above Administrative and Financial Sanction was accorded for an amount of Rs. 100,00,000/- (Rupees One crore only) under the head of account 2515-00-102-79-34 (Plan) for the scheme State Institute of Rural Development (SIRD) for the year 2016 – 17.

2. Since the State Government has to provide matching contribution equivalent to the Central share (excluding Central share towards the salary of core faculty members), from the budget allocation an amount of Rs. 56.34 lakhs (Rupees Fifty six lakh and Thirty four thousand only) were released to the SIRD being the 50% of the matching state share as per the proceedings read as 2nd paper above.

3. The Commissioner for Rural Development as per the letter read as 3rd paper has requested to accord special sanction to release the balance amount of Rs. 43.66 lakhs to KILA-CHRD being the State share of funds in anticipation of the Central Share due to KILA-CHRD.

4. Government have examined the matter in detail and are pleased to accord sanction to release an amount of Rs.43.66 lakhs (Forty three lakhs and Sixty six thousand only) under the head of account 2515-00-102-79-34 (Plan) being the State share of funds in anticipation of Central Share due to KILA-CHRD.
