As per letter read as 3rd paper above, Sri.V.S.Sivakumar MLA of Thiruvananthapuram LAC has requested take necessary action for the installation of LED High Mast Lights at 30 locations in his Constituency by utilizing the funds from Legislative Assembly Constituency-Asset Development Scheme.

- 2. The Chief Engineer, LSGD as per letter read as 4th paper above has submitted the estimate prepared by M/s KSIE Ltd for the project.
- 3. Government have examined the matter in detail and are pleased to accord administrative sanction for the project of installation of high mast lights in Thiruvananthapuram LAC at an estimated cost of Rs. 1,63,85,000/- (Rupees One crore sixty three lakh eighty five thousand only) utilizing funds from the Asset Development fund of Sri. V.S.Sivakumar, MLA for the year 2016-17. The execution of the work will be subject to the guidelines issued by the Government in the orders read above and in strict adherence of all departmental formalities.
