ORDER

Based on the recommendation of Vigilance Department in Government read as 1st paper above Sri.S.K.Sanal Kumar, Public Works Overseer of Fort Zonal Office. Thiruvananthapuram Corporation was suspended from Service as per GO read as 2nd paper above, as a case has been registered against him in VC 02/2015/SIU-I under section 13 (1) (d) r/w 13 (2) of PC Act 1988 and Sec. 477 and 120 (B) IPC before the Hon'ble Court of Enquiry Commissioner and Special Judge, Thiruvananthapuram.

Sri S.K.Sanal Kumar challenged the Government Order read above before the Hon'ble Kerala Administrative Tribunal by preferring OA(EKM)-1660/2016. The Hon'ble KAT vide its order dated, 01.11.2016 has directed the first respondent (State of Kerala represented by the Secretary, LSGD) to consider and pass appropriate orders on Annexure A3 petition in accordance with the dictum laid down in Ajay Kumar Choudhari's case supra, within a period of one month from the date of receipt of a copy of the order. In Annexure A3 representation, read as 3rd above, the applicant has requested to reinstate him in service.

The suspension of the incumbent was based on the Vigilance case. Hence decision on revoking of suspension has to be taken by the suspension review committee. Now Vigilance Department in Government as per paper read as 5th above has recommended to reinstate the suspended officer in service subject to ratification of the Suspension review Committee.

Government have examined the matter in detail and are pleased to revoke the suspension of Sri.S.K.Sanal Kumar, Public Works Overseer of Fort Zonal Office. Thiruvananthapuram Corporation, as per G.O. cited as 2nd above and to reinstate him into service with immediate effect subject to ratification by the Suspension review Committee.

The Chief Engineer, LSGD will issue necessary posting order to Sri.S.K.Sanal Kumar, Public Works Overseer out side Thiruvananthapuram District forthwith.

The Appeal Petition read as 3rd above is disposed of accordingly and the Orders of Hon'ble Kerala Administrative Tribunal is thus complied with.
