## <u>ORDER</u>

As per Order read as 1<sup>st</sup> paper above, the Director of Urban Affairs issued transfer and postings in the cadre of Junior Health Inspector Grade-II in Municipal Common Service. In the above order Smt. Indulekha L, Junior Health Inspector Grade-II, Cochin Corporation was transferred to Moovattupuzha Municipality. Aggrieved by this order, Smt. Indulekha L, Junior Health Inspector Grade-II, Cochin Corporation filed representation read as 2<sup>nd</sup> paper above before Government. In the representation, the incumbent requested to cancel her transfer and retain her in Kochi Corporation.

2. In connection with the above transfer, Smt. Indulekha L, Junior Health Inspector Grade-II also filed O.A No.1748/16 before the Kerala Administrative Tribunal. The Hon. Tribunal in the Order read as 3<sup>rd</sup> paper above directed the Government to consider Annexure A4(representation)

at the time of General transfers or within three months from the date of receipt of a certified copy of the order, which ever is earlier.

- 3. Government examined the matter in detail and found that transfer and posting of Junior Health Inspectors is not vested with Government and the competent authority in this regard is Director of Urban affairs. In the above circumstances the Director of Urban Affairs is directed to consider the request of Smt. Indulekha L, Junior Health Inspector Grade-II at the time of general transfer 2017 or within 3 months from 03.04.2017 as per norms
- 4. The Annexure A4 representation read as 3<sup>rd</sup> paper above filed by Smt. Indulekha L is disposed of accordingly in compliance with the Court Order read as 3<sup>rd</sup> paper above.
