ORDER

As per order read as 1st paper above, the Director of Urban Affairs issued transfer and postings in the cadre of Typist in Municipal Common Service. In the above order Shri. Sarin B, Senior Grade Typist, Thiruvanathapuram Corporation and Smt. Shyla Beegum N, U D Typist, Thiruvanathapuram Corporation were transferred to Guruvayoor Municipality and Maradu Municipality respectively, for administrative conveniences.

2. In connection with the above transfer, Shri. Sarin B, and Smt. Shyla Beegum N also filed O.A No.1708/16 before the Kerala Administrative Tribunal. The Hon. Tribunal in the interim Order dated 27.07.2016 stayed the operation and implementation of the order of transfer of the applicants and both of them are continuing in Thiruvanathapuram Corporation on the strength of the above interim order.

- 3. As per representation read as 2nd paper above the applicants filed representation before Government with a request to cancel their transfer and to retain them at Thiruvanathapuram.
- 4. Also the Hon. Tribunal in the final Order dated 03.03.2017 directed the Government to see that the claim of the applicants duly considered at the time of ordering general transfer or within a period of three months from the date of receipt of a certified copy of the order, which ever is earlier.
- 5. Government examined the matter in detail and found that transfer and posting of Typist category is vested Director of Urban affairs. There are norms fixed by Government for effecting transfer and posting of employees.
- 6. In the above circumstances the Director of Urban Affairs is directed to consider the request of Shri. Sarin B, Senior Grade Typist and Smt. Shyla Beegum N, U D Typist to retain them in Thiruvananthapuram, strictly in accordance with the transfer norms fixed by Government at the time of general transfer 2017-18 or within 3 months from 05.04.2017.
- 7. The Annexure MA 1 &MA1(a) representations read as 2nd paper above filed by Shri. Sarin B and Smt. Shyla Beegum N is disposed of accordingly in compliance with the Court Order read as 3rd paper above.
