3. Government have examined the matter in detail and are pleased to accord administrative sanction for the following works from the Legislative Assembly Constituency – Asset Development Scheme (LAC-ADS) for the year 2016-17 of Adv. U.Prathibha Hari MLA, Kayamkulam LAC.

- (i) Project ID 1166- Construction of protection wall and forming footpath with concrete slab for thodu from south of Eruva bridge, Karipuzha canal cheerp to east of Kayyalakkal road in ward No. 12 of Kayamkulam Municipality - Rs. 25.00 lakhs
- (ii) Project ID No. 1164 – Construction of Pulimukku Puthenveetil Junction road, Kayamkulam - Rs.10.00 lakhs
- (iii) Project ID No. 1165 Construction of Muhayidheen Palli Kuttukulangara road, Kayamkulam - Rs.25.00 lakhs

- (iv) Project ID No. 1168 Construction of KPAC Junction Lekshmi Theatre Road - Rs.30.00 lakhs
- (v) Project ID No. 2856 Renovation of Manayasseri Bridge and approach road in Kayamkulam Municipality - Rs.35 lakh
