2. In compliance to the judgment read as 3<sup>rd</sup> paper above, the petitioners and the concerned parties were heard in person on 10.04.2015. Government have examined the matter in detail on the basis of the evidences adduced at the time of hearing and other relevant documents, and are hereby

decline the proposal for regularisation of the farm labourers in view of the directions contained in the judgment read as 1<sup>st</sup> paper above.
