ORDER

As per letter read as 2nd above, Sri.Suresh Kurup, MLA of Ettumanoor LAC has requested to issue Administrative Sanction for the work 'Kattachira – Pazhooraath Bhadraa Devi Temple road in ward No.7 of Ettumanoor Municipality'

2. The Chief Engineer, LSGD as per letter read as 3rd above, has submitted the Detailed Project Report for the above work.

Government have examined the matter in detail and are pleased to accord administrative sanction for the work "Kattachira – Pazhooraath Bhadraa Devi Temple road in ward No.7 of Ettumanoor Municipality" at an estimate cost of Rs.9,43,556/- (i.e. after deducting the service tax of Rs.56,444/- from the estimate amount Rs.10,00,000/- as the same is not allowable for public road works as per GoI notification No. 25/2012-Service Tax dated 20.06.2012) under LAC-ADS of Sri.Suresh Kurup, MLA of Ettumanoor LAC for the year 2016-17. The work shall be executed in strict adherence of all departmental formalities and in tune with the guidelines issued by the Government in the Order read above. The expenditure for the work will be debited under the head of account '4515-00-800-96-Projects under LAC ADS (NP)'.


