ORDER

As proposed by Sri.R.Ramachandran, MLA representing Karunagapally Constituency, Kerala State Industrial Enterprises Ltd, Thiruvananthapuram has furnished detailed estimate of the work Supply and Installation of Highmast lights in 23 locations in Karunagapally LAC at an estimate cost of Rs.84.25 Lakhs (Rupees Eighty Four Lakh and Twenty Five Thousand only) as per the reference read as 4th paper above to accord Administrative Sanction and Special Sanction. The respective Grama Panchayats passed and forwarded resolutions in this regard.
