ORDER

Sri.Aboobacker Siddique E.P., was recruited through KPSC as Overseer Grade I and was subsequently promoted as Assistant Engineer (Civil). He has joined duty as Assistant Engineer on 25.04.2011 FN. He has not passed the obligatory Departmental Tests during the normal period of probation in the cadre of Assistant Engineer. The last date of the series of test in which he passed was 23-08-2016. Hence his period of probation has to be extended up to 25-08-2016 AN, so as to declare the probation on 24-08-2016 FN. He has availed commuted leave for 23 days during the probation period. As per the proceedings read as second paper above, the Chief Engineer, LSGD has extended the period of probation in respect of Sri.Aboobacker Siddique E.P., in the cadre of Assistant Engineer up to 17.05.2014 AN and as per the letter read as 1st paper above, he has requested for extension of the period of probation of the incumbent up to 25.08.2016 AN. The Chief Engineer has reported that the incumbent is otherwise eligible to have declared the period of probation but for his non passing of the obligatory Departmental Tests.

2. Government have examined the matter in detail and are pleased to extend the period for probation in respect of Sri. Aboobacker Siddique E.P., in the cadre of Assistant Engineer from 18.05.2014 to 25.08.2016 AN as per Rule 21 of Part II KS & SSRs, 1958.
