ORDER

As proposed by Sri. Ramachandran Kadannappally , Hon'ble Minsiter for Ports, Archeology & Museum & M.L.A. representing Kannur Constituency the Chief Engineer, Local Self Government Department , as per the letter read as 2nd paper above has furnished detailed estimate for the work '**Construction of Valiyannur Ksheerolpadaka sahakarana Sangham Building - Kannur Corporation**' (Project ID 1636) at an estimate cost of **Rs.10.00 Lakh (Rupees Ten Lakh Only)** under LAC ADS for according Administrative Sanction.

Government have examined the matter in detail and are pleased to accord administrative sanction for the work '**Construction of Valiyannur Ksheerolpadaka sahakarana Sangham Building - Kannur Corporation**' (Project ID 1636) at an estimate cost of **Rs.10.00 Lakh(Rupees Ten Lakh Only)** under the LAC-ADS of Sri. Ramachandran Kadannappally , Hon'ble Minsiter for Ports, Archeology & museum & M.L.A. representing Kannur Constituency with special sanction to take up the work for execution following all departmental formalities and in tune with the guidelines issued in the Government Order read as 1st paper above and subsequent Government orders subject to the following conditions.

- 3) The directions issued vide G.O(P) No.591/2015 shall scrupulously be followed.
