### ORDER

As per paper read as 1<sup>st</sup> above, the Ministry of Drinking Water and Sanitation, Government of India, conveyed the release of an amount of Rs. 98,02,23,000/- (Rupees Ninety Eight Crore Two Lakh Twenty Three Thousand only) towards the second instalment of Grant in Aid during 2016 -2017 for the implementation of Swach Bharat Mission (Gramin) to the Consolidated Fund of the State, as follows

1. Normal Allocation ( Non SCP & Non TSP ) - ( Sanction Order No.247/2016-17 dated 20.02.2017 )	Rs. 81,96,32,000/-
2.Special Component Plan for Scheduled Castes - (Sanction Order No.248/2016-17 dated 20.02.2017)	Rs. 14,46,76,000/-
3.Tribal Area Sub Plan - (Sanction Order No. 249/2016- 17 dated 20.02.2017)	Rs. 1,59,15,000/-
<b>Total</b>	<b>Rs. 98,02,23,000/-</b>

2) Subsequently, the Executive Director, Suchitwa Mission has requested Government to accord sanction for the release of the central share of **Rs. 98,02,23,000/- (Rupees Ninety Eight Crore Two Lakh Twenty Three Thousand only)** from the Head of Account 2515-00-101-65(01) and the corresponding state share of **Rs.65,34,82,000/- (Rupees Sixty Five Crore Thirty Four Lakh Eighty Two Thousand only)** calculated in the ratio of 60:40 for the three components as follows, from the Head of Account 2515-00-101-65(02) with permission to the Commissioner for Rural Development to draw and to transfer credit the amount to the Special TSB Account No.99 of the Executive Director, Suchitwa Mission at District Treasury, Thiruvananthapuram.

1.Normal Allocation (Non SCP& Non TSP)	Rs.54,64,21,333/-

As per paper read as 4<sup>th</sup> above, Finance agreed to release an amount of Rs.61.5 Crore from the H/A '2515-00-101-65-(01)-Central share (P)' and Rs. 41 Crore from the H/A '2515-00-101-65-(02)- State share (P)' and also the amount Rs. 60.8705 Crore provided through additional authorisation as per Order read as 3<sup>rd</sup> above with permission to the Commissioner for Rural Development to draw and to transfer credit the amount to the dedicated Special TSB Account No.99 of Executive Director, Suchitwa Mission kept at the District Treasury, Thiruvananthapuram.

Government have examined the request of the Executive Director, Suchitwa Mission in detail on the basis of the concurrence given by the Finance department as paper read as 4<sup>th</sup> above and are pleased to accord sanction for the release of an amount of **Rs.61.5 Crore** from the H/A '2515-00-101-65-(01)-Central share (P)' and **Rs. 41 crore** from the H/A '2515-00-101-65-(02)- State share (P)' and also the amount of **Rs. 60.8705 Crore** provided through additional authorization as per Order read as 3<sup>rd</sup> above, with permission to the Commissioner for Rural Development to draw and to

transfer credit the amount to the dedicated Special TSB Account No.99 of Executive Director Suchitwa Mission maintained at the District Treasury, Thiruvananthapuram.


