2. The Chief Engineer, PWD, Roads and Bridges as per letter read as 3rd paper above, has submitted the Detailed Project Reports for the above works.

3. Government have examined the matter in detail and are pleased to accord administrative sanction for the following works from the Asset Development fund for the year 2016-17 of Sri.M.Mukesh, MLA of Kollam LAC.
