E.S.Bijimol, MLA representing Peerumade Constituency as per the letter read as 4th paper above, the Director, Kerala State Nirmithi Kendra (KSNK), Thiruvananthapuram has submitted detailed estimate for the work Improvement of Vandiperiyar Choorakkulam Road in Vandiperiyar Grama Panchayat under LAC-ADS for the year 2016-17 at an estimated cost of Rs. 20,00,000/- (Rupees Twenty Lac only) for according Administrative Sanction.

2) Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work Improvement of Vandiperiyar Choorakkulam Road in Vandiperiyar Grama Panchayat under LAC-ADS for the year 2016-17 of Smt. E.S.Bijimol, MLA representing Peerumade Constituency at an estimated cost of Rs. 20,00,000/- (Rupees Twenty Lac only) with Special Sanction to take up the works for execution as deposit work through KSNK, subject to exclude the service Tax and also subject to the resolutions passed by the concerned Local Bodies in this regard, following all departmental formalities and in tune with the guidelines issued in the Government Order read as 1st paper above and subsequent Government orders. The Chief Engineer, Local Self Government Department should take further action to

deposit the required amount to KSNK, the executing agency, as envisaged in the Circular read above.
