ORDER

2. Government have examined the proposal and are pleased to accord sanction for the deputation of Sri. Y. Abdul Salam, Village Officer, Pattithara, Palakkad as Assistant District Mission Co-ordinator in Kudumbashree District Mission Office, Kollam for a period of one year from the date of joining duty in Kudumbashree, as per the conditions stipulated under Rule 140(c) Part I KSRs and with the following conditions stipulated in the Government Order and Circular read above:

1. The Officer on deputation will be relieved of his duties on the date of expiry of the sanctioned period unless the competent authority has, with requisite approval, extended the period of deputation, in writing, prior to the date of its expiry. In the event of the officer overstaying, he will be liable to disciplinary action and the period of overstay will not be counted for the purpose of pension and that any increment due during the period of overstay will be deferred with cumulative effect, till the date on which the officer rejoins his parent cadre and the officer will be precluded from drawing pay and allowances from the date on which the sanctioned term of foreign service expires.
2. When the officer on deputation is promoted to a higher post in his parent department, he will be reverted back to his parent Department, unless specific orders retaining the officer on deputation even after his promotion are issued by Government on the specific request of the borrowing Department.
