ORDER

- Sri. Sasidharan. V, Accountant, Thachanattukara Gramapanchayat, Palakkad filed OA-672/2017 before the Hon'ble Kerala Administrative Tribunal seeking for a direction to grant retrospective promotion with effect from 03.01.2017 and to grant seniority from that date
- 2. By disposing OA- 672/2017 the Hon'ble Kerala Administrative Tribunal in their order read as 1st paper above have directed the 1st Respondent, ie Government to take decision on Annexure A9 representation after hearing the applicant and any person likely to be affected within a period of two months from the date of receipt of a certified copy of this order which will be produced by the applicant along with a copy of the OA.
- 3. In pursuance to the direction of the Hon'ble Kerala Administrative Tribunal the Applicant was heard by the under secretary on 09.06.2017. The applicant deposed that he may be restored of his seniority with retrospective effect and to get a suitable posting in a nearby panchayat, to his residence.
- 4. The applicant has been working as Senior Clerk in Pallassana Gramapanchayat, Palakkad and included as serial no. 1339 in the gradation list of the Senior Clerks as on 01.08.2016. In Annexure A5 promotion order, the persons included after serial no.153 are junior to the applicant. The person included as serial no. 154 is Mr. Aneesh.K.T, is the immediate junior who is included in Annexure A1 gradation list as serial No. 1400.

- 5. The Director of Panchayats has reported that provisional promotion is being as per Rule 9(c), KS&SSR. Promotion to the post of Senior Clerks from Accountant category is done from the seniority list of Senior Clerks. Retrospective effect to the promotion in respect of Sri. Sasidharan.V to the post of Accountant shall be considered during the regularisation of provisional promotion and the seniority will be protected. The applicant will be given transfer to pallasana Grama Panchayat during the General Transfer 2017.
- 6. Government have examined the matter in detail and are pleased to order that the Director of Panchayats will consider retrospective effect to the promotion in respect of Sri. Sasidharan.V to the post of Accountant during the regularisation of provisional promotion and also to fix the seniority of the incumbent in between serial No153 and 154 of Annexure A5. Nobody else is likely to be affected duly regularisation of provisional promotion.
- 7. The order of Hon'ble Kerala Administrative Tribunal read as 1st paper above is thus complied.
