ORDER

Government of India had released an amount of Rs.1,7689000/-, Rs.1,02,59,000/-, Rs.74,29,000/- as 1st component of Grant-in aid under General, SCP and TSP components of NRLM respectively as per sanction orders read as 2nd paper above. As per Government Order 3rd paper above Government of Kerala released the Central share along with matching state share in the ratio 75:25. Subsequently, Government of India have revised the funding pattern between Centre and State from 75:25 to 60:40 and this revised funding pattern is made applicable to all central share released from 1st April, 2015 vide letter read as 4th paper above. As per Government Order 5th paper above Commissioner for Rural Development has been authorise for the release of an amount of Rs.1,17,21,999/- (One Crore Seventeen Lakh Twenty one thousand Nine hundred and Ninety Nine) being the balance amount of State Share of 1st instalment of NRLM/Ajeevika for the year 2015-16. As per letter read as 6th paper above the Executive Director, Kudumbashree has requested to release the balance amount of State share of the 1st instalment of Grant-in-aid already released during the year 2015-16 as per the revised funding pattern.

Government after having examined the matter in detail, are pleased to authorise the

Commissioner, Rural Development Department to release an amount of Rs.70,333/- (Seventy Thousand Three hundred and Thirty Three) from the Head of account 2225-02-197-48(04)(P) as the pending State share of the 1st instalment of NRLM/Ajeevika for the year 2015-16.
