ORDER

As per the Proceedings read as 1st paper above, the Secretary, TRIDA provisionally promoted Smt.A.D.Abhanand, Overseer/ D'man Grade I(H), TRIDA to the post of Assistant Town Planner (In pre-revised scale Rs.20740-36140) subject to the condition that the promotion as such shall be regularised only with the approval of the Departmental Promotion Committee of TRIDA.

(2) The Departmental Promotion Committee held on 08.12.2016, observed that the Special Rule applicable to TRIDA is the KDA Rule 2015, in the matter of direct recruitment, by transfer and promotion. As per the Rule, out of the total strength in every post for direct recruitment (through KPSC)/by transfer(from D'man Gr.I) appointment is set apart in the ratio of 1:1. Unless otherwise the Special Rules are amended, the ratio enshrined in the Special Rule cannot be ignored or over ruled by the board considered. The DPC also observed that it is a serious latches committed from the part of TRIDA and flat violation of Special Rules and decided that any one from among the D'man Gr.I cannot be considered for promotion for want of vacancy as the cadre strength already highly exceeded from the ratio to be maintained. It was also observed by the DPC that the provisional promotion, if any, ordered is only a departmental arrangement and will not attach any seniority or privileges to claim promotion.

(3). Government have examined the matter in detail and found that the decision taken by the Departmental Promotion Committee in this case based on the ratio stipulated in the Special Rules applicable to the authority is in order and therefore it is ordered to revert Smt.A.D.Abhanand, Assistant Town Planner to Overseer/ D'man Grade I, by reverting Sri.Ajay.R.S. who has been promoted to the post of Overseer Gr.I in the promotion vacancy of Smt.A.D.Abhanand to his original post of Overseer Gr.II with immediate effect .
