**ORDER**

Sri.Rajan C., was recruited through Kerala Public Service Commission as Overseer Grade II. He was subsequently promoted as Assistant Engineer (Civil) and joined duty on 05.04.2010 FN. He has not passed the obligatory Departmental Tests during the normal period of probation in the cadre of Assistant Engineer. He has attained the age of 50 years on 25.05.2014 as his date of birth being 25.05.1964. Hence, he was exempted from passing the obligatory departmental tests. Therefore his period of probation has to be extended up to 26-05-2014 AN, so as to declare the probation on 25-05-2014 FN. As per the proceedings read as second paper above, the Chief Engineer, LSGD has extended the period of probation in respect of Sri.Rajan C., in the cadre of Assistant Engineer up to 04.04.2013 AN and as per the letter read as 1<sup>st</sup> paper above, he has requested for the extension of the period of probation of the incumbent up to 26.05.2014 AN. The Chief Engineer has reported that the incumbent is otherwise eligible to have declared the period of probation but for his non passing of the obligatory Departmental Tests.

2. Government have examined the matter in detail and are pleased to extend the period for probation in respect of Sri.Rajan C., in the cadre of Assistant Engineer from 05.04.2013 to 26.05.2014 AN as per Rule 21 of Part II KS & SSRs, 1958.
