ORDER

As per the Government Order read as 1st paper above, Shri.Gopakumar R.S. has been appointed to the post the Health Officer in Municipal Common Service in the existed vacancy of Kozhikode Corporation. The Secretary, Kozhikode Corporation as per the letter read as 3rd paper above has informed that there is no sanctioned post of Health Officer Grade III in the Corporation and the sanctioned post is that of Health Officer Grade I in the scale of pay of Rs.77,400-1,15,200. In addition to that there are 6 Medical Officer posts and 1 LMO in the Corporation in the scale of pay of Rs.39500-83000/-. Hence, as per the proceedings read as 3rd paper above, Shri. Gopakumar R.S. has been appointed as Medical Officer (Alopathy)/Health Officer Grade III in the scale of pay of Rs.39,500-83000/- and additional charge of the post of Health Officer has been given to him in anticipation of Government approval. The Secretary, Kozhikode Corporation has requested to make suitable modification in the Government Order read as 1st paper above and to ratify the action in having given the additional charge of the post of Health Officer in Kozhikode Corporation to Shri. Gopakumar R.S.

2. The Director of Urban Affairs as per the letter read as 4th paper above, has reported that there is no sanctioned post of Health Officer Grade III in Kozhikode Corporation and that Medical Officer (Alopathy)/Lady Medical Officer/Assistant Health Officer are the post with equal scale of pay and has requested to amend the Government Order as requested by the Secretary, Kozhikode Corporation and to ratify the action of Secretary, Kozhikode Corporation in having given the additional charge of Health Officer to Dr. R.S. Gopakumar.

3. Government have examined the matter in detail and are pleased to order that the appointment of Dr. R.S. Gopakumar to the post of Health Officer effected as per the Government Order read as 1st paper above is amended and is posted as Medical Officer (Alopathy) at Kozhikode Corporation. The action of Secretary, Kozhikode Corporation in having given the additional charge of Health Officer in Kozhikode Corporation to Dr. R.S. Gopakumar is also ratified.

4. The Government Order read as 1st paper above stands modified to the above extent.
