ORDER

Government vide GO read above have accorded authorization of ₹350,79,60,158/- (Rupees Three Hundred and Fifty crore Seventy Nine lakh Sixty thousand One hundred and Fifty Eight only) as additional funds equal to that of the unspent balance for World Bank aided Kerala Local Government Service Delivery Project under Development Fund at the end of the financial year 2016-17.
