Local Self Government Department - Panchayat Establishment – Disciplinary action initiated against Sri. Abdu Rahiman M.K, Secretary, Puduppady Grama Panchayat - Dropped - Orders issued.

ORDER

Based on a Source Report, Vigilance & Anti Corruption Bureau has conducted a Quick Verification against Sri. Abdu Rahiman. M.K, Secretary, Puduppady Grama Panchayat and submitted report as per 1st paper read above, regarding the allegation of amassment of wealth and acceptance of bribery. Quick Verification revealed that Sri. Abdu Rahiman had assets worth Rs. 4,70,000/- at the beginning of the check period with an income of Rs. 54,68,889/-. Assets acquired during the check period for worth Rs. 35,37,105.70/- and the expenditure calculated was Rs. 21,27,910/-. The dis-appropriate assets are calculated, as Rs. 1,96,126/- by taking market value as the properties which comes to about 3.6%. There are no evidences to prove that the suspected officer received bribery from the part time sweepers appointed at Puduppady Grama Panchayat Office. Vigilance Department recommended to take departmental action against Sri. Abdu Rahiman. M.K. Secretary, Puduppady Grama Panchayat for violation of Rule 26 of Kerala Government Servants Conduct Rules 1960, by not obtaining previous sanction for transaction of immovable properties.

Government have examined the matter in detail. It is seen that the suspected officer did not commit any grave irregularity in imposing on him penalty like pension deduction as per KSR Part III. He was retired from service on 31.5.2016. In the circumstances, taking a lenient view, no action may be taken against Sri. Abdu Rahiman. M.K, former Secretary (retired), Puduppady Grama Panchayat. Hence the disciplinary action initiated against Sri. Abdu Rahiman. M.K, former Secretary, Puduppady Grama Panchayat, Kozhikode is dropped and order accordingly. The Director of Panchayats will take necessary action in this matter.
